The TM-m30II-F features enhanced functionality, connectivity and allows the user to free up valuable counter space thanks to the compact, discreet design and small footprint. It includes a certified Technical Security Module (TSE)<sup>1</sup> required by the German Cash Security Ordinance (Kassensicherungsverordnung) and is fully compliant with the Technical Guideline BSI TR-03153.

## Simple compact design

The TM-m30II-F is based on a simple, compact cube design with a very small footprint. This discreet design fits seamlessly into most environments and is not compromised by the TSE as it's internal. Available in black or white.

## Legal compliance

The TSE in the TM-m30II-F keeps you compliant with the German Cash Security Ordinance (Kassensicherungsverordnung), which came into effect on 1st of January 2020. The built-in microSD-TSE is BSI-certified<sup>1</sup> and comes with a digital certificate that's valid for 5 years from the date of manufacture (Epson service is available for the whole validity period) and standard 3 years warranty<sup>2</sup>.

## Cost effective

Unlike other subscription and monthly payment alternatives, you only pay once to be compliant, with no extra or hidden fees<sup>3</sup>.

## Ease of use

The TM-m30II-F is the successor to the iconic TM-m30-F receipt printer and features enhanced connectivity to accommodate the needs of growing businesses, including versions with USB, Ethernet and Bluetooth. This is an ideal option for POS systems where the TSE cannot be easily integrated (e.g. tablet-based systems). And unlike other fiscal solutions, the TM-m30II-F doesn't even need an internet connection to keep you on the right side of the fiscal law.
