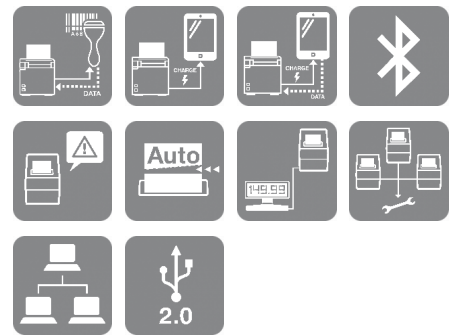
Legal compliance

The built-in microSD-TSE is BSI-certified¹ and comes with a digital certificate valid for 5 years from the date of manufacture (Epson service is available for the whole validity period) and standard 3 years warranty².
